
Adopted on JAN 23 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager is hereby authorized and empowered to do by City forces the necessary work for the modification of traffic signals at Mission Boulevard and Grand Avenue, Front and Ash Streets, State and Ash Streets, Columbia and Ash Streets, India and Ash Streets, Kettner Boulevard and Ash Street, and Pacific Highway and Ash Street, and for the removal of the traffic signal at Kettner Boulevard and Market Street, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.

2. That the expenditure of \$10,575 is hereby authorized from Gas Tax Fund 220 of The City of San Diego solely and exclusively for the purpose of providing funds for the modification of traffic signals described above.
