

RESOLUTION NO. 207267 JAN 30 1973

APPROVING MAP OF BAHIA VISTA TERRACE SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled "BAHIA VISTA TERRACE Being a subdivision of a portion of the Southwest Quarter of Quarter Section 103 of Rancho De La Nacion as shown on Map No. 166 filed in the office of the County Recorder of the County of San Diego, May 11, 1869 in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Olive Avenue, Altamont Drive, Altamont Circle, Altamont Place, Reo Drive, Reo Court and Plumas Street, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Rachael Avenue, adjacent and contiguous to Lots 16 and 17, all as shown on this map within this subdivision; together with the easements with

the right of ingress and egress for the construction and maintenance of drainage and water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of drainage and water facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
