That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA, Business and Transportation Agency, Office of Traffic Safety, for upgrading of the Police Ambulance Program, under the terms and conditions set forth in the form of agreement on file in the Office of the City Clerk as Document No. 742519.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer from the Unallocated Reserve (53.30) to the Police Department (15.21) the sum of \$7,700, to be used solely and exclusively for upgrading the Police Ambulance Program.
