

RESOLUTION NO. 207276 JAN 30 1973

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO REMOVING CERTAIN PARKING PROHIBITIONS  
AT VARIOUS STREET LOCATIONS WITHIN THE CITY OF  
SAN DIEGO.

WHEREAS, this Council heretofore adopted Resolutions Nos. 149612, 172032 and 179268 pursuant to Section 86.04 of the San Diego Municipal Code which imposed certain parking prohibitions and restrictions on various City streets in the Loma Portal area, State College area, and Cal Western area of the City of San Diego; and

WHEREAS, pursuant to the authority granted the City Manager in Section 86.06 of the San Diego Municipal Code, additional parking prohibitions and restrictions were imposed on other City streets in the Sun Gold Point/La Jolla area and La Jolla Farms area in said City; and

WHEREAS, it has now been determined that said parking prohibitions and restrictions do not conform and are inconsistent with Council Policy No. 700-27, adopted May 21, 1970, and are therefore no longer necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the parking prohibitions and restrictions presently in effect for the various City streets and portions thereof described in Exhibit A, consisting of two sheets and attached hereto and made a part thereof, be and the same are hereby ordered removed.

2. That the City Manager be and he is hereby directed to remove all curb markings, signs, and the like which are inconsistent with the provisions of this resolution and to conform, if required, said curb markings and signs on said streets in accordance with Council Policy No. 700-27's provisions and criteria.

3. That Resolutions Nos. 149612, 172032 and 179268 be and the same are hereby ordered rescinded.
