

RESOLUTION No. 207282


Adopted on JAN 30 1973

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized, empowered and directed to execute and deliver on behalf of The City of San Diego a final release and discharge of WITCO CHEMICAL CORPORATION from any and all claims and demands as they relate to the antitrust lawsuit against Union Oil Co. of Calif., Standard Oil Co. of Calif., Chevron Asphalt Co., Shell Oil Co., Douglas Oil Co. of Calif., Atlantic Richfield Co., Gulf Oil Corp., Industrial Asphalt, Inc. and Wilshire Oil Co. of Calif., which is currently on file in the Northern District Court of California, Civil Case Nos.
