

RESOLUTION NO. 207287 JAN 30 1973

WHEREAS, the U. S. Army Corps of Engineers has entered into a Public Works contract for the dredging of approximately 300,000 cubic yards of material from the entrance to Mission Bay; and

WHEREAS, said contract provides for the disposal of said dredge material in sites as follows: 100,000 cubic yards in Ocean Beach between the Pier and the groin at the extension of Cape May Avenue, and 200,000 cubic yards in Mission Beach, between Capistrano Place and San Luis Obispo Place; and

WHEREAS, said contract includes an additive alternate for the disposal of 200,000 cubic yards in lieu of the Mission Beach site in Pacific Beach between Pacific Beach Drive and Law Street; and

WHEREAS, said alternate site in Pacific Beach would greatly improve the public beach in that location and would be of more benefit to the beaches of the City of San Diego than placement at the Mission Beach site; and

WHEREAS, in order for the U. S. Corps of Engineers to select said additive alternate Pacific Beach Disposal Site, the participation of The City of San Diego is required in the sum of \$130,000.00 in said dredging contract; and


WHEREAS, the City Manager recommends that the City Council authorize the expenditure of said \$130,000.00 from Capital Outlay Fund 245 for the purpose of participation in said contract in order to improve the public beach located in Pacific Beach between Pacific Beach Drive and Law Street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be, and he is hereby authorized to enter into a standard contract with the U. S. Army Corps of Engineers participating in a dredging contract referenced DACW09-73-B-0018 providing for the selection by the U. S. Corps of Engineers of additive alternate 4 on page B-3 of said referenced document so that 200,000 cubic yards of dredged material may be placed in Pacific Beach between Pacific Beach Drive and Law Street for the improvement of the public beach in that location.

2. That the expenditure of \$130,000 from Capital Outlay Fund 245 for the above purpose be, and the same is hereby authorized and approved.
