

RESOLUTION NO. 207294 FEB 1 1973

APPROVING MAP OF VILLA MONTEREY UNIT NO. 2 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled "VILLA MONTEREY UNIT NO. 2 Being a subdivision of portions of Lots 3 and 12 of Rosedale Tract, in the City of San Diego, County of San Diego, State of California, according to the Map thereof No. 825, filed in the office of the County Recorder of San Diego County, California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets, to wit: Guisante Lane, Guisante Terrace, Canforero Terrace, Rimpark Way, Apple Tree Drive, Antigua Boulevard, Park Crest Way, Park Crest Lane, Guinda Court, and Quemado Court, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, those items listed in paragraphs 1 and 2 of the certificate signed by the Owners for: easements with the right of ingress and egress for the construction and maintenance of sewer and drainage

facilities, and open space; as granted and shown on said map and subject to the conditions expressed therein.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and those items listed in paragraphs 1 and 2 of the certificate signed by the Owners are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
