
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the UNITED STATES OF AMERICA, executed in favor of The City of San Diego, bearing date of December 14, 1972, conveying to said City an easement and right of way for street, slope and drainage purposes over, under, upon, along and across portions of Quarter Sections 79 and 80, Rancho de la Nacion, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed as Parcels 1 and 2 is hereby dedicated as and for a public street and the same is hereby named PARADISE VALLEY ROAD.

That the expenditure of \$10,000 is hereby authorized from Gas Tax Fund 220 solely and exclusively to provide funds (and supplementing Resolution No. 198289, adopted October 23, 1969, in this amount) for the acquisition of right of way for Paradise Valley Road.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the San Diego County Recorder.
