BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file a certified copy of this resolution for record in the office of the Recorder of San Diego County.

LEGAL DESCRIPTION

All that portion of Pueblo Lots 1279 and 1296 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the Office of the County Recorder of said County of San Diego, November 14, 1921, as Miscellaneous Map No. 36, being a 30.00 foot wide strip of land lying Easterly and Southeasterly of the following described line:

Commencing at the Northwest corner of Lot 2 of Torrey Pines Christian Church, according to the Map thereof No. 4969 filed in the Office of said County Recorder; thence South  $00^{\circ}51'06''$  West along the Westerly line of said Lot 2, 47.34 feet; thence North  $58^{\circ}25'36''$  West, 101.40 feet to the Southeasterly line of Via Posada as said street is established and dedicated on the date of this instrument; thence North  $27^{\circ}10'52''$  East along said Southeasterly line, a distance of 79.85 feet; thence North  $62^{\circ}49'08''$  West, 47.00 feet to the Northwesterly line of said Via Posada; said point also being on the Northwesterly boundary line of La Jolla Shores Heights Unit No. 5 according to the Map thereof No. 7455 filed in the Office of said County Recorder; thence South  $27^{\circ}10'52''$  West (Record per Deed South  $27^{\circ}10'25''$  West), along said boundary of said Map 7455, a distance of 106.61 feet to the TRUE POINT OF BEGINNING; thence South  $27^{\circ}07'54''$  West, 75.00 feet to the beginning of a tangent 260.00 foot radius curve concave Easterly; thence Southwesterly and Southerly along the arc of said curve through a central angle of  $32^{\circ}08'57''$ , a distance of 145.89 feet; thence tangent to said curve South  $05^{\circ}01'03''$  East, 29.19 feet to a terminus.

The sidelines of the above strip of land shall be prolonged or shortened so as to terminate Southerly in a line that bears South  $89^{\circ}30'15''$  East through said point of terminus.
