

RESOLUTION NO. 207319 FEB 6 1973

WHEREAS, The City of San Diego is the owner of a portion of the Southwest Quarter of Section 11, Township 12 South, Range 1 East, San Bernardino Meridian; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for overhead electrical powerline purposes over and across said property to serve a private agricultural owner adjacent to City-owned Water Utilities Department land; and

WHEREAS, the purposes for which the easement is required are public purposes as the City benefits from any future service of this facility; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, this project is exempt from an Environmental Assessment by reason of paragraph a(4) of the San Diego Municipal Code Section 69.0302; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, in consideration of the benefits to accrue to the people of said City, the Mayor and City Clerk of said City be and they are hereby authorized and empowered to execute for and on behalf of The City of San Diego a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for overhead electrical powerline purposes over and across a portion of the Southwest Quarter of Section 11, Township 12 South, Range 1 East, San Bernardino Meridian, as more particularly described in the form of deed of easement on file in the office of the City Clerk as Document No. 742620.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed to the Property Director of The City of San Diego for further handling.
