That payment for services rendered under the terms of this agreement shall be made from the appropriate developer's funds on deposit in City Fund 302 for the purposes of defraying City costs incurred in connection with their applications to do land development and other associated work; and that a total of not to exceed \$10,000 is authorized to be expended from the appropriate accounts in the said Fund 302 for this purpose.
