

RESOLUTION NO. 207325 FEB 6 1973

A RESOLUTION PROTESTING THE TAX SALE OF
A CERTAIN PARCEL OF REAL PROPERTY AS
AUTHORIZED BY THE BOARD OF SUPERVISORS
OF SAN DIEGO COUNTY AND AUTHORIZING THE
ENTERING OF AN AGREEMENT TO PURCHASE
SAID PARCELS.

(Lots 1 through 4, inclusive,
Block 12 of Paradise Valley
Heights)

WHEREAS, the Board of Supervisors of San Diego County
by Resolution No. 13, adopted October 31, 1972, authorized
the sale of Parcel No. 8001/582-053-01 of tax-deeded land
at public auction; and

WHEREAS, it is the desire and intent of The City of
San Diego, under the provisions of Chapter 8, Part 6,
Division 1 of the Revenue and Taxation Code, to enter into
an agreement for purchase of said parcel in order to use
said land for park purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San
Diego, as follows:


1. That The City of San Diego, a municipal corporation,
hereby protests the sale of Parcel No. 8001/582-053-01 as
authorized by the Board of Supervisors of the County of
San Diego, and does hereby declare its intent to enter into
an agreement for purchase of said parcel for park purposes.

2. That the intended public use of said parcel of
land when purchased by The City of San Diego is for park
purposes.

3. That the City Manager of The City of San Diego be and he is hereby authorized and empowered to enter into an agreement to purchase said parcel of land for the sum of one hundred seventy dollars (\$170.00), plus the cost of advertising as expended by the office of the County Tax Collector.

4. That in the event the assessee redeems the parcel after the Tax Collector has expended funds for advertising, The City of San Diego hereby agrees to reimburse the Tax Collector for such expenditures and the Treasurer of The City of San Diego is hereby authorized and directed to issue a warrant to cover such expense.
