

RESOLUTION NO. 207326 FEB 6 1973

WHEREAS, there are various public streets more particularly described and shown on Drawing No. 14939-D on file in the office of the City Clerk as Document No. 742637 within the City of San Diego which are variously known and named, some officially, others unofficially; and

WHEREAS, said various descriptions and names have caused confusion and are generally misleading; and

WHEREAS, it appears to be in the public interest to officially establish and change the names of the above referenced streets; and

WHEREAS, the Planning Commission of The City of San Diego has recommended approval of said name changes and designations;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Beyer Boulevard be and the same is hereby designated as the official name of the street now known as North Vista Avenue, Beyer Boulevard, U. S. 101 Alternate, and National Avenue between the San Diego City and County limits to the north and the frontage road east of Interstate 805;

That East Beyer Boulevard be and the same is hereby designated as the official name of the street now known as North Vista Avenue, Main Street, Beyer Boulevard and East Beyer Boulevard between the new Beyer Boulevard, renamed by this resolution, and Interstate 5;

That Beyer Way be and the same is hereby designated as the official name of the street now known as Byer Way, Beyers Way and Beyer Way between the San Diego City and County limits to the north and the new Beyer Boulevard, renamed by this resolution;

That National Avenue between Interstate 5 and the International Border be and the same is hereby officially renamed Via Nacional;

All as more particularly shown and described in Drawing No. 14939-D on file in the office of the City Clerk as Document No. 742637 which shall govern as to all details therein.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to file a certified copy of this resolution in the office of the County Recorder and the County Surveyor of San Diego County.
