

RESOLUTION NO. 207328 FEB 6 1973

WHEREAS, the Employer-Employee Relations Policy of The City of San Diego provides for the appointment of a Management Team by the City Council to represent the City in Employer-Employee relations pursuant to the provisions of said Policy; and

WHEREAS, on January 27, 1970, the City Council, by Resolution No. 198957, designated the City Manager and Personnel Director or their designated representatives to perform the Management Team functions; and

WHEREAS, on January 16, 1973, the City Council amended Council Policy No. 300-1 to provide guidelines for an expanded role for the Civil Service Commission in the salary setting process; and

WHEREAS, the City Council has determined that a potential conflict exists between the Personnel Director's role as a member of the Management Team and as Secretary to the Civil Service Commission; and

WHEREAS, to avoid such potential conflict, the City Council on January 16, 1973, directed that the Personnel Director not be included as a member of the Management Team; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution No. 198957, dated January 27, 1970, be and the same is hereby rescinded.

2. That the City Manager or any person or persons so designated by him to act as his designated representative(s) be and is hereby appointed by the City Council as the Management Team of The City of San Diego in accordance with the Employer-Employee Relations Policy of said City.
