

RESOLUTION NO. 207332 FEB 6 1973

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING ITS INTENT TO ENTER INTO CERTAIN FREEWAY AGREEMENTS WITH THE STATE OF CALIFORNIA INVOLVING THE PROPOSED DEVELOPMENT OF STATE HIGHWAY ROUTES 8, 15 AND 163 AND CALLING FOR A PUBLIC HEARING ON THE SAME.

WHEREAS, this Council has heretofore entered into various freeway agreements with the Division of Highways, Department of Public Works, State of California, regarding the proposed development of Interstate 15 within the City of San Diego; and

WHEREAS, this Council by Resolution No. 205149, adopted March 14, 1972, did request the California Division of Highways to expedite the expansion of said Interstate 15 to an eight-lane thoroughfare and to advance construction schedules to the earliest possible date in order to adequately provide for increased traffic volumes created by Mira Mesa, Tierrasanta and similar developments; and

WHEREAS, in order to facilitate the requested expansion of Interstate 15, it is now necessary, pursuant to the California Streets and Highways Code, Section 100.2, for The City of San Diego to enter into five freeway agreements with the State Division of Highways, the effect of which, if executed, will be the permanent closure of several City streets, the relocation of certain City streets, the construction of frontage roads and other local roads, and other construction affecting City streets; and

WHEREAS, the Streets and Highways Code, Section 100.22, requires that the City Council shall, prior to entering into any agreement contemplated by Section 100.2 of the Streets and Highways Code, conduct a public hearing on the subject; and

WHEREAS, the proposed freeway agreements are on file in the office of the City Clerk under Documents Nos. 742613, 742614, 742615, 742616, and 742617, and are available for public inspection; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That the City Council of The City of San Diego hereby declares and expresses its intention to enter into the above referenced freeway agreements with the Division of Highways, Department of Public Works, State of California, under the terms and conditions set forth in the form of the agreements on file in the office of the City Clerk under the above referenced document numbers, said agreements pertaining to the following sections of freeway in the City of San Diego:

- (1) Interstate 8/Interstate 15 Interchange Area
 - (a) Route 8--between 0.1 mile west of Route 15 and 0.2 mile east of Fairmount Avenue
 - (b) Route 15--between 0.5 mile south of Route 8 and 0.1 mile north of Route 8;
- (2) Interstate 15 (through Murphy Canyon)--Route 15 between 0.4 mile north of Friars Road and 0.2 mile north of Clairemont Mesa Boulevard;

- (3) Interstate 15 (Route 52 Interchange Area)
Route 15 from 0.2 mile north of Clairemont Mesa Boulevard to 0.7 mile north of Route 52;
- (4) Interstate 15 (in area of Miramar Naval Air Station) and Route 163 (southerly of Interstate 15)
 - (a) Route 15--from 1.3 miles north of Clairemont Mesa Boulevard to 0.5 mile north of Miramar-Pomerado Road
 - (b) Route 163--from 1.0 mile south of Murphy Canyon Road to Route 15;
- (5) Interstate 15 (North of Mira Mesa)
Route 15 in the City of San Diego--between 0.5 mile north of Pomerado-Miramar Road overcrossing and 0.4 mile north of Poway-Penasquitos Boulevard overcrossing.

That said agreements contemplate the closing of the following City streets or portions thereof:

- (a) Camino del Rio North--for approximately 500 feet immediately west of the existing ramp connecting southbound Murphy Canyon Road and westbound I-8.
- (b) Tierrasanta Boulevard--from Murphy Canyon Road to a point approximately 1800 feet to the northeast.
- (c) Kearny Villa Road--from "Avenue H" to a point approximately 500 feet south of "Harris Plant Road."
- (d) Kearny Mesa Road--from a point approximately 800 feet south of Miramar Road to a point approximately 200 feet further south.

San Diego, California, are hereby fixed as the time and place
when and where any and all interested persons having any objec-
tions or comments to the freeway agreements herein proposed may
appear and be heard. That the Clerk of said City be and he is
hereby directed to cause this resolution of intention to be
published at least ten (10) days before the date of said hearing
in the City's Official Newspaper, a daily newspaper published and
circulated in said City.
