WHEREAS, on October 30, 1972, at a public hearing, the Housing Advisory and Appeals Board approved said findings; NOW, THEREFORE,

1. The buildings situate on the property described above are declared to be public nuisances.

2. The City Attorney is authorized and instructed to take appropriate legal action to abate the aforesaid nuisances.
