That the City Manager be and he is hereby fully authorized and empowered to execute for and on behalf of said City a second amendment to agreement with the CALIFORNIA COUNCIL ON CRIMINAL JUSTICE, under CCCJ Project No. 0270, Contract A-261-70, providing grant funds for The City of San Diego Municipal Command and Control System, by providing a thirty (30) day extension thereto by changing the Duration of Project from "December 1, 1970 to June 30, 1972" to "December 1, 1970 to July 31, 1972," all other provisions of said contract on file in the office of the City Clerk as Document No. 736721 to remain as previously agreed upon and executed.
