That the expenditure of \$18,500.00 is hereby authorized out of the Capital Outlay Fund No. 245 of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF ADDITIONAL SHUFFLEBOARD COURTS AT NORTH PARK SENIOR CITIZENS CENTER, in the City of San Diego, and related costs.
