BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled "CORONADO HIGHLANDS UNIT NO. 1 Being a subdivision of a portion of Lot 2, Socosite Tract No. 1, Map No. 4945, in the City of San Diego, County of San Diego, State of California, according to official plat thereof and a portion of the Southwest One Quarter, of the Northeast One Quarter of Section 28, Township 18 South, Range 2 West, San Bernardino Meridian, together with those portions of 19th Street and Coronado Avenue as dedicated to public use, in the City of San Diego, County of San Diego, State of California, according to the United States Government Survey.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portions of public streets, to wit: Raedel Court, Elm Avenue, Raedel Drive, a portion of 19th Street, and a portion of Coronado Avenue, for public purposes, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
