

RESOLUTION NO. 207370 FEB 15 1973

APPROVING MAP OF MISSION VALLEY INDUSTRIAL
PARK UNIT NO. 4 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, Licensed Land Surveyor, and entitled "MISSION VALLEY INDUSTRIAL PARK UNIT NO. 4 Being a subdivision of those portions of Lots 1, 2 and 3 of the subdivision of Lots 61, 62 and the Easterly portion of Lot 63 of Rancho Mission, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1550, filed in the office of the County Recorder of San Diego County, March 20, 1913, lying within the boundary of Record of Survey 5837, filed in the office of the County Recorder of San Diego County, April 20, 1961.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portion of street, to wit: portion of Mission Gorge Road, for public purposes, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication for public street those portions of Lots 10, 12, 13 and 14 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and said Council has rejected those portions of Lots 10, 12, 13 and 14 marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
