

RESOLUTION NO. 207380 FEB 15 1973

RESOLUTION OF THE CITY
COUNCIL OF THE CITY OF SAN DIEGO
DECLARING ITS INTENTION TO HOLD A
PUBLIC HEARING TO CONSIDER A PROPOSED
ORDINANCE WHICH WOULD ESTABLISH A LOAD
LIMIT ON A PORTION OF STATE ROUTE 163
SOUTH OF ITS INTERSECTION WITH INTER-
STATE 8 AND THROUGH BALBOA PARK.

WHEREAS, on January 25, 1972, the City Council directed the City Manager and the City Attorney to prepare an ordinance for submission for approval to the State Department of Public Works pursuant to California Vehicle Code Section 35702, which ordinance would prohibit the use of Route 163 southerly of Interstate 8 through Balboa Park to commercial vehicles with a load limit of one ton or more, effective with the opening of Interstate 805; and

WHEREAS, such an ordinance was prepared and submitted to the State Division of Highways; and

WHEREAS, the Division of Highways reviewed the proposed ordinance and has indicated that, "it is satisfactory to proceed with [a] public hearing on the basis of [the draft ordinance]."; and

WHEREAS, the Division of Highways indicated that, "After completion of the public hearings and study of the reasonableness of the alternate routes, final consideration will be given for approval by the Department of Public Works."; and

WHEREAS, the Division of Highways has conducted a study of the reasonableness of the alternate routes specified in the proposed ordinance but has indicated that final consideration for approval of the proposed ordinance will not be given until after public hearings have been held; and

WHEREAS, Section 35705 of the Vehicle Code of the State of California provides that notice of such public hearings shall be published as provided in Section 6064 of the Government Code and that the time for submission of objections to the proposed ordinance shall not expire and the hearing may not be held less than 60 days after the first publication of notice; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That notice is hereby given that APR 24 1973, 1973 at 9:30 o'clock a.m., in the Council Chambers of the City Administration Building, Community Concourse, 202 "C" Street, in the City of San Diego, California, is hereby fixed as the time and place when and where any and all persons having any objections to the proposed ordinance to establish a load limit on a portion of State Route 163, a copy of which proposed ordinance is on file in the office of the City Clerk as Document No. 742702, may appear and show cause why said proposed ordinance should not be introduced and adopted by the City Council.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to cause this resolution of intention to be published once a week for four successive weeks in the City's official newspaper, a daily newspaper published and circulated in said City.
