1. That the City Attorney or his authorized representative be and he is hereby authorized to incur all necessary expenses in connection with an appearance and participation on behalf of The City of San Diego in those certain hearings being held before the California Public Utilities Commission in the matter of The Pacific Telephone and Telegraph Company's Application No. 53587 for rate increase requests in the amount of \$328,000,000; and

2. That the City Auditor and Comptroller be and he is hereby authorized and empowered to transfer the sum of \$4,500 within the 100 Fund from the Unallocated Reserve (53.30) to the Allocated Reserve (53.20) for the sole and exclusive purpose of providing funds in connection with said appearance and participation by the City Attorney.
