RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 203414, AS AMENDED BY RESOLUTION NO. 203994, FOR THE IMPROVEMENT OF GENESEE AVENUE, MARLESTA DRIVE, LINDA VISTA ROAD AND MOUNT ALIFAN DRIVE.

WHEREAS, the Council of The City of San Diego, California, has heretofore approved Resolution of Intention No. 203414, as amended by Resolution No. 203994, for the construction of certain improvements as are more particularly described therein, all in accordance with plans and profiles referred to in said Resolution of Intention, as amended; and

WHEREAS, the public interest, convenience and necessity require that certain changes and modifications be made in the work proposed to be done under the Resolution of Intention, as amended, at a decrease in the estimated cost of work of \$28,456.93 and an increase of \$8,311.59, resulting in a net decrease of \$20,145.34; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of GENESEE AVENUE, MARLESTA DRIVE, LINDA VISTA ROAD AND MOUNT ALIFAN DRIVE, heretofore filed in the office of the City Clerk as Document No. 736842 and approved by Resolution No. 203413, as amended by Document No. 737739 and approved by Resolution No. 203994, be and the same are hereby

amended to conform with City of San Diego Engineering Department Drawings No. 14609-1-D through No. 14609-20-D, filed in the office of the City Clerk as Document No. 742757, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.
