BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following street in said City:

Both sides of UPSHUR STREET from Rosecrans Street westerly to the southeasterly property line of Cabrillo Elementary School.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said street, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
