

RESOLUTION NO. 207427 FEB 27 1973

APPROVING MAP OF VILLA TRINIDAD UNIT NO. 2 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by JOHN M. LEACH, Registered Civil Engineer, and entitled "VILLA TRINIDAD UNIT NO. 2 Being a subdivision of portions of Lots 26, 27 and 38 of Rosedale Tract, Map No. 825 filed in the office of the County Recorder of San Diego County, January 21, 1897, in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets, to wit: Tambor Road, Cartulina Road, Pallon Way, Tambor Court, Siglo Court, Sombra Court, Pallon Court, Risa Circle, Risa Court, and Retrato Court, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Tierrasanta Boulevard, adjacent and contiguous to Lots 52, 53, 174 and 175, all as shown on this map within this subdivision; together with the open space easements over all of Lots 173, 174 and 175, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the open space easements and the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
