

RESOLUTION NO. 207436 FEB 27 1973

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CITY MANAGER TO EXECUTE, FOR AND ON BEHALF OF SAID CITY, FIVE FREEWAY AGREEMENTS WITH THE DIVISION OF HIGHWAYS, DEPARTMENT OF PUBLIC WORKS, STATE OF CALIFORNIA FOR THE PROPOSED DEVELOPMENT OF STATE HIGHWAY ROUTES 8, 15 AND 163.

WHEREAS, pursuant to Resolution No. 207332 adopted on FEB 6 1973, this Council did express its intent to enter into certain freeway agreements with the Division of Highways, Department of Public Works, State of California; and

WHEREAS, pursuant to Section 100.22 of the California Streets and Highways Code a public hearing was conducted with all persons present being afforded an opportunity to hear and to be heard regarding the matter of The City of San Diego's entering into the above referenced freeway agreements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, those freeway agreements with the Division of Highways, Department of Public Works, State of California, covering the proposed development of State Highway Routes 8, 15 and 163 as set forth below within the City of San Diego, under the terms and conditions set forth in the form of agreements on file in the office of the City Clerk under the following document numbers:

A. I-8/I-15 Interchange Area

(1) Route 8 - between 0.1 mile west of Route 15 and 0.2 mile east of Fairmount Avenue.

(2) Route 15 - between 0.5 mile south of Route 8 and 0.1 mile north of Route 8.

B. I-15 (through Murphy Canyon) -

Route 15 between 0.4 mile north of Friars Road and 0.2 mile north of Clairemont Mesa Boulevard.

C. I-15 (Route 52 Interchange Area) -

Route 15 from 0.2 mile north of Clairemont Mesa Boulevard to 0.7 mile north of Route 52.

D. I-15 (in area of Miramar N.A.S.) and

Route 163 (southerly of I-15).

(1) Route 15 - from 1.3 mile north of Clairemont Mesa Boulevard to 0.5 mile north of Miramar - Pomerado Road.

(2) Route 163 - from 1.0 mile south of Murphy Canyon Road to Route 15.

E. I-15 (past Mira Mesa) - Route 15 in

the City of San Diego - between 0.5 mile north of Pomerado - Miramar Road O.C. & 0.4 mile north of Poway - Penasquitos Boulevard O.C.
