That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF WATER RELOCATIONS FOR STATE ROUTE 163, BETWEEN AERO DRIVE AND CLAIREMONT MESA BOULEVARD, San Diego, California

filed in the office of the City Clerk of The City of San Diego, California, on FEB 23 1973, and bearing official Document No. 742751, be, and the same are hereby approved.



BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
