RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO DECLARING INTENTION TO  
APPROPRIATE FUNDS FOR PAYMENT OF  
ASSESSMENTS RELATING TO PROCEEDINGS  
BY CITY OF ESCONDIDO FOR ASSESSMENT  
DISTRICT NO. 1-1971 (BEAR VALLEY  
PARKWAY) IN THE CITY OF ESCONDIDO,  
CALIFORNIA.

WHEREAS, the City Council of the City of Escondido is contemplating the initiation of assessment proceedings for the construction of certain street improvements together with appurtenant work in what is known as ASSESSMENT DISTRICT NO. 1-1971 (BEAR VALLEY PARKWAY) in the City of Escondido, said proceedings to be pursuant to the provisions of the "Improvement Act of 1911," Division 7 of the Streets and Highways Code of the State of California; and

WHEREAS, the City of Escondido is desirous prior to initiating proceedings to best insure the salability of the bonds under said proceedings and so as to allow said City to represent the aggregate amount of assessments that will go to bond, requests from this City Council of The City of San Diego a resolution of intention to appropriate funds to pay the assessment levied against property owned by The City of San Diego, said property receiving a benefit from the contemplated improvements in said assessment district; and

WHEREAS, The City of San Diego is desirous that the City Council of the City of Escondido proceed with the works and improvements within said assessment district and deems

it to be in the best public interest and convenience to declare the intention of said City to appropriate the funds for payment of any assessments levied against properties owned by The City of San Diego immediately upon the confirmation of any special assessments by the City of Escondido; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

A. The above recitals are all true and correct.

B. The City of San Diego hereby declares its intention to appropriate the necessary funds to pay the amount of any legally issued assessment against property owned by The City of San Diego, and within the boundaries of what is to be known as ASSESSMENT DISTRICT NO. 1-1971 (BEAR VALLEY PARKWAY) in the City of Escondido.


C. That said funds would be due and payable immediately upon the completion of the works of improvement and upon confirmation of the final assessment by the City of Escondido, and no liability would be created against The City of San Diego until the work has been completed and the final assessments have been confirmed by said City of Escondido.

D. Said assessment amounts would be payable to the City of Escondido within thirty (30) days following any confirmation of the assessment for said assessment district

in the manner and form as set forth in the "Improvement Act of 1911," being Division 7 of the Streets and Highways Code of the State of California.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$303,755.60 within the Water Fund 502 from the Unallocated Reserve (67.91-3495) to Lands and Rights of Way (67.51-3463) and authorizing an expenditure of \$303,755.60 for said improvements.
