

RESOLUTION NO. 207445 MAR 1 1973

WHEREAS, Norton Sharpe has by affidavit stated that coupons from Bonds No. A992-A993 and A1620 and 1621 of The City of San Diego, 1970 Penasquitos Sewer Bonds have become lost, mislaid, stolen or destroyed; and

WHEREAS, there is no cost to issue new coupons; and

WHEREAS, Section 53460 et seq. of the California Government Code permits a city to issue new coupons to replace lost or destroyed coupons; and

WHEREAS, Norton Sharpe has provided a Bond for Securities Lost or Destroyed No. 8632604, issued by the Fidelity and Deposit Company of Maryland, holding The City of San Diego harmless in the amount of \$700.00; and

WHEREAS, this Council is satisfied by competent proof that coupons from Bonds No. A992-A993 (2 coupons at \$168.75 each) and A1620 and 1621 (2 coupons at \$181.25 each) from the 1970 Penasquitos Sewer Bonds have been lost or destroyed;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer be and he is hereby authorized to issue two (2) new No. A992-A993 coupons and two (2) new A1620 and 1621 coupons (four coupons totaling \$700.00) from the 1970 Penasquitos Sewer Bonds to replace those lost or destroyed.

BE IT FURTHER RESOLVED, that the City Treasurer place in his file the affidavit of Norton Sharpe attesting to the loss and the indemnity agreement of Fidelity and Deposit Company of Maryland.
