WHEREAS, the Federal Bureau of Investigation's Law Enforcement School on Police Community Relations is conducting a forum to discuss current problems in community relations, urban police problems and training needs; and

WHEREAS, the specialized law enforcement course in Police Community Relations will be held in Quantico, Virginia on March 12 through March 23, 1973; and

WHEREAS, the total cost of said program, excluding the police officer's salary, is to be paid by the Federal Bureau of Investigation; and


WHEREAS, this training will enable the San Diego Police Department to exchange ideas and acquire latest information in respect to this vital area of law enforcement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Captain H. French of the San Diego Police Department be authorized to perform travel to Quantico, Virginia for the purpose of attending the Federal Bureau of Investigation's Law Enforcement School (Police Community Relations) for the period March 12 through March 23, 1973.

BE IT FURTHER RESOLVED, that all travel and associated expenses, with the exception of Captain French's salary during this period, shall be at no expense to the City but shall be paid by the Federal Bureau of Investigation.
