


RESOLUTION No. 207448

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$326,462.00 by Larry Montoya, an Individual, dba Larry Montoya, General Building Contractor, for the SITE DEVELOPMENT AND REMODELING OF SAN DIEGO TRANSIT CENTRAL OPERATING FACILITY PARKING AREA IMPROVEMENTS, in the City of San Diego, California, including Additive Alternates 1 and 2, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742403.
2. That the expenditure of \$370,000.00 is hereby authorized out of the Transit Central Operating Facility Fund (Fund No.2572) of the City of San Diego solely and exclusively for the purpose of providing funds for SITE DEVELOPMENT AND REMODELING OF SAN DIEGO TRANSIT CENTRAL OPERATING FACILITY PARKING AREA IMPROVEMENTS in the City of San Diego, and related costs.
