

RESOLUTION NO. 207461 MAR 6 1973

RESOLUTION AWARDING A CONTRACT TO IMPROVE AND ESTABLISH THE GRADE ON CALIFORNIA STREET BETWEEN VINE AND CHALMERS STREETS AND BEAN STREET BETWEEN KURTZ AND CALIFORNIA STREETS, AND AUTHORIZING THE EXPENDITURE OF FUNDS FOR CITY'S CONTRIBUTION TOWARDS SAID IMPROVEMENT.

WHEREAS, the Purchasing Agent of The City of San Diego, California, as authorized by City Council Resolution No. 183404, did on November 8, 1972, publicly open, examine and declare all sealed proposals or bids for doing the work and improvement described in Resolution of Intention No. 206376, which Resolution of Intention is hereby expressly referred to for description of said work and improvement and for all particulars relative to the proceedings under said Resolution of Intention; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council of The City of San Diego, California, hereby rejects all said proposals or bids except that herein mentioned and hereby awards the contract for doing said work and improvement to the lowest regular responsible bidder, to wit:

GRIFFITH COMPANY

at the prices named in the bid of said bidder on file in the office of the City Clerk; and

That the City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.

BE IT FURTHER RESOLVED, That the expenditure of \$6,400 is hereby authorized out of Gas Tax Fund 219 of The City of San Diego solely and exclusively for the purpose of providing funds for the City's contribution toward the cost of paving and otherwise improving California Street between Vine and Chalmers Streets and Bean Street between Kurtz and California Streets, pursuant to Resolution of Intention No. 206376 under the 1911 Act proceedings, and related costs.
