That the lands previously conveyed to The City of San Diego for the purpose of a public street and incidents thereto through, over, under, along and across a portion of Lot 1 of Rancho Caster, as more particularly described in the legal description attached hereto as Exhibit A, be and the same are hereby set aside and dedicated as and for a public street and the same is hereby named MAJESTIC DRIVE.

LEGAL DESCRIPTION

All that portion of Lot 1, Rancho Caster, reserved for Future Street, according to the Map thereof No. 6523, filed in the Office of the San Diego County Recorder, October 23, 1969, more particularly described as follows:

Commencing at the Southwest corner of said Lot 1, Rancho Caster, being also the intersection of the Southeasterly line of Beyer Way, 60.00 feet wide as located and established as of the date of this instrument, with the East-West centerline of Section 26, T18S R2W; thence South $89^{\circ}36'43''$ East along said centerline a distance of 1552.55 feet to a point on the arc of a 230.00 foot radius curve, concave Southeasterly, a radial to which bears North $29^{\circ}12'13''$ West, being also the TRUE POINT OF BEGINNING; thence Northeasterly along the arc of said curve through a central angle of $29^{\circ}35'30''$, a distance of 118.79 feet to a point, a radial to which bears North $00^{\circ}23'17''$ East; thence South $89^{\circ}36'43''$ East along a tangent line a distance of 299.62 feet; thence South $00^{\circ}20'36''$ East along the North-South centerline of said Section 26, T18S R2W a distance of 30.00 feet to a point of intersection with said East-West centerline of Section 26, T18S R2W; thence North $89^{\circ}36'43''$ West along said East-West centerline a distance of 413.58 feet returning to the TRUE POINT OF BEGINNING.
