

RESOLUTION No. 207465


Adopted on MAR 6 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of B. CARL BOSSARD and DOROTHY BOSSARD, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date of January 15, 1973, conveying to said City an easement and right of way for street purposes over, under, upon, along and across a portion of the Northeast Quarter of Section 31, Township 14 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named RICKERT ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the County Recorder of San Diego County.
