That the acceptance by the City Manager of that deed of SAN DIEGO TRUST AND SAVINGS BANK as Trustee for P.T. 707, executed in favor of The City of San Diego, bearing date of January 15, 1973, conveying to said City an easement and right of way for street purposes over, under, upon, along and across a portion of Lot 1, Block 60 of City Heights, according to Map thereof No. 1007, filed October 3, 1906 in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named UNIVERSITY AVENUE.

That the City Clerk is hereby authorized and directed to transmit the foregoing said deed to the Property Director of The City of San Diego for further handling.
