
Adopted on MAR 8 1973

Fleet Space Theater of the San Diego Planetarium, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 742865.

That the expenditure of \$40,000 is hereby authorized from Planetarium Bond Fund 920 solely and exclusively to provide funds for the purposes stated above.
