Penick & Sons, Inc., a Corporation, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY WABASH BOULEVARD, OCEAN VIEW BOULEVARD, 40TH STREET AND 'Z' STREET, 43RD STREET, LOGAN AVENUE, 45TH STREET, AND BOSTON AVENUE (E.D.A. Project No. 07-11-01227 - Contract # 19) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742407.
2. That the expenditure of \$50,000.00 is hereby authorized out of the Special Fund No. 2714 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY WABASH BOULEVARD, OCEAN VIEW BOULEVARD, 40TH STREET AND 'Z' STREET, 43RD STREET, LOGAN AVENUE, 45TH STREET, AND BOSTON AVENUE in the City of San Diego, and related costs.
