WHEREAS, The City of San Diego is the owner of portions of Pueblo Lots 1101 and 1102 of the Pueblo Lands of San Diego and Lot B, Block 443 of Old San Diego; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for an overhead electrical powerline and for underground electrical facilities upon, over, under, in, across and through said property to provide for growing power demands in the westerly end of Mission Valley; and

WHEREAS, the purposes for which said easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That in consideration of the benefits to accrue to the people of said City the Mayor and the City Clerk of said City be and they are hereby authorized and empowered

to execute for and on behalf of The City of San Diego a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for an overhead electrical powerline and for underground electrical facilities upon, over, under, in, across and through portions of Pueblo Lots 1101 and 1102 of the Pueblo Lands of San Diego and Lot B, Block 443 of Old San Diego; as more particularly described in the form of deed of easement on file in the office of the City Clerk as Document No. 742917

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed to the Property Director of The City of San Diego for further handling.
