WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property described in the form of quitclaim deed on file in the office of the City Clerk as Document No. 742918, be and the same is hereby authorized to be sold by negotiation for the sum of one hundred fifteen dollars (\$115) to Gladys Kohn and Helen Weinberg, each as to an undivided 1/2 interest.
- 2. That the Mayor and the City Clerk of said City be and they are hereby authorized and empowered to execute for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document No. 742918, quitclaiming to GLADYS KOHN and HELEN WEINBERG, each as to an undivided 1/2 interest, a portion of the Southeast Quarter of the Southeast Quarter of Quarter Section 63, Rancho de la Nacion, as more particularly described in said form of quitclaim deed.
