

RESOLUTION No. 207504


Adopted on MAR 13 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SECURITY TITLE INSURANCE COMPANY, as Trustee P. T. No. 1165, executed in favor of The City of San Diego, bearing date of January 24, 1973, conveying to said City an easement and right of way for street purposes through, over, under, along and across a portion of Section 32, Township 14 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named GOLD COAST DRIVE, and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named MAYA LINDA ROAD.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of San Diego County.
