

RESOLUTION NO. 207507 MAR 13 1973

WHEREAS, National Steel and Shipbuilding Company, (NASSCO), has requested that the City Council consider submitting to the San Diego Coastal Regional Commission an application for exclusion from the requirements of the California Coastal Zone Conservation Act of 1972 of property it leases from the San Diego Unified Port District; and

WHEREAS, an application for exclusion may only be submitted by The City of San Diego and should involve a zoned area, not separate leaseholds or ownerships; and

WHEREAS, the Council has received a communication from the San Diego Unified Port District advising of its interest "in working toward the exclusion from the permit area of certain of the filled tidelands upon which important economic units of our community are located" and soliciting the cooperation of the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. The Council expresses its desire to forward to the San Diego Coastal Regional Commission an application for exclusion from the California Coastal Zone Conservation Act of 1972 of lands of the San Diego Unified Port District leased to NASSCO and others on that tideland located south of Eighth Avenue and north of Chollas Creek lying westerly of the adjudicated mean high tideline.

2. The San Diego Unified Port District is urged to prepare and complete an application satisfying the requirements of that Act to the Council at the earliest possible time.

3. All departments of the City are hereby directed to cooperate with the San Diego Unified Port District, NASSCO and other Port tenants in the preparation of said application.
