

RESOLUTION NO. 207508 MAR 13 1973

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CERTAIN CHANGES AND MODIFICATIONS IN THE WORK FOR THE IMPROVEMENT OF GENESEE AVENUE, MARLESTA DRIVE, LINDA VISTA ROAD AND MOUNT ALIFAN DRIVE AS DESCRIBED IN RESOLUTION OF INTENTION NO. 203414.

WHEREAS, this City Council did on August 12, 1971, adopt its Resolution of Intention No. 203414 declaring its intention to order the construction of certain improvements in the City of San Diego; and

WHEREAS, this City Council did on FEB 20 1973, adopt its Resolution No. 207399 proposing to make certain changes and modifications in the work as described in said Resolution of Intention; and

WHEREAS, the hearing has been held on said proposed changes, all in the manner and form prescribed by law, and objections not having been made by the owners of one-half of the area of the property proposed to be assessed, and the contractor having filed a written consent to the making of said changes, and this Council now having jurisdiction to make said changes and modifications;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The public interest and convenience require certain changes and modifications in the work for the assessment district originally set forth in Resolution of Intention No. 203414, which

changes and modifications are duly described and set forth in Resolution No. 207399 adopted by this Council on FEB 20 1973, 1973. This Council hereby orders said changes and modifications as set forth in said last noted resolution.

Section 2. That the contract for said improvement entered into for the doing of the work shall be modified to include modifications ordered by this resolution.
