Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled "GATEWOOD HILLS UNIT NO. 8 Being a subdivision of a portion of Rancho San Bernardo in the City of San Diego, County of San Diego, State of California, according to Map thereof recorded in Book 2, Page 462 of Patents, records of said County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following street: Gibraltar Court, for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

The Clerk of said City is hereby directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street is accepted on behalf of the public as heretofore stated; and that said easements with the right of ingress and egress for the construction and maintenance of water, sewer, water reservoir and pumping plant, are accepted on behalf of The City of San Diego, a municipal corporation, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
