BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$11,368.50 by G. Spikes and W. Love Masonry and Cement Contractors, a Partnership for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY BOUNDARY STREET, FRANKLIN AVENUE, SAN MIGUEL AVENUE, LOS PINOS AVENUE, SAN PASQUAL STREET AND OCEAN VIEW BOULEVARD, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742408.
2. That the expenditure of \$14,500.00 is hereby authorized out of Special Fund No. 2714 of the City of San Diego, solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY BOUNDARY STREET, FRANKLIN AVENUE, SAN MIGUEL AVENUE, LOS PINOS AVENUE, SAN PASQUAL STREET AND OCEAN VIEW BOULEVARD in the City of San Diego, and related costs.
