BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled "DIVISION HIGHLANDS UNIT NO. 1 Being a subdivision of a portion of the Northwesterly Quarter of Quarter Section Lot 79 and a portion of the Southerly Half of the Northeasterly Quarter of Quarter Section Lot 104 of the Rancho De La Nacion in the City of San Diego, County of San Diego, State of California, according to the Map thereof by Morrill No. 166, on file in the County Recorder's Office of said San Diego County, together with a portion of Division Street as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets, to wit: Honeysuckle Lane, Grewia Street, Daisy Avenue, and Daisy Place, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

right of ingress and egress for the construction and maintenance of sewer facilities, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of sewer facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
