BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to do by City forces all the work for the modification of traffic signals at Juan Street-Taylor Street, Garnet Avenue-Lamont Street, 43rd Street-El Cajon Boulevard, and 54th Street-El Cajon Boulevard, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.

2. That the expenditure of \$10,950 is hereby authorized from Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the traffic signal modification designated above and related costs.
