


RESOLUTION No. 207532

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to do by City forces all the work of installation of two 6" meters, two backflow assemblies and two vaults for the Torrey Pines Golf Course, to be set, one each, on existing 6" services at 11580 and 10726 North Torrey Pines Road in the City of San Diego, California, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.
