1. That the bid of \$35,269.60 by Silver Strand Masonry and Cement Contractors, a partnership, for IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY 27TH STREET, "A" STREET, 32ND STREET AND HIGHWAY 94 (CONTRACT 17), in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742012.
2. That the expenditure of \$45,000 is hereby authorized out of Special Fund No. 2714 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY 27TH STREET, "A" STREET, 32ND STREET AND HIGHWAY 94 (CONTRACT 17), in the City of San Diego, and related costs.
