BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of Hawthorne Machinery Co. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of ONE (1) BULLDOZER WITH HYDRAULIC TILTING "U" BLADE at a cost of \$84,872.00 terms 2% 30 days, plus sales tax, less trade-in allowance of \$7,000.00 on one 1966 trashmaster compactor; plus options 1A, 1B and 1C. guaranteed parts cost not to exceed \$36,750.00 maximum cost at end of 10,000 hours use; plus alternate options 2A, 2B and 2C guaranteed repurchase price of \$33,000.00 at the end of 10,000 hours or 5 years and option 3A guaranteed repurchase price of \$66,000.00 within 2,000 hours or 1 year.
