That the City Manager be, and he is hereby authorized and empowered to execute for and on behalf of said City, an agreement with BROWN & CALDWELL CONSULTING ENGINEERS to conduct a rate analysis and cost of service study of The City of San Diego Water Utilities Department for a maximum fee of \$26,500, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 742991.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$26,500 within Water Operating Fund 500 Reserve (67.49-3494) to Professional Services (67.27-3295), and that the expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the above services.
